The Roadside Assistance and Vehicle Recovery NOS have now been reviewed by expert working groups across the UK and changes/additions have been suggested. In order to see the updated draft documents click <u>here</u>. A summary of the changes is as follows:

- There was much discussion about duty of care and the need for a robust handover procedure. It was suggested that 'the importance of adhering to a robust, documented handover procedure' be added to all relevant units.
- All references to 'high energy' to be amended to 'alternative fuel' to be relevant for all vehicle types, not just EV.
- 'Breakdown' to refer to 'scene', 'incident' to refer to 'site' throughout relevant units.
- RR01 (Carry out roadside diagnostic activities on motor vehicles) -
 - New K9 added 'the importance of adhering to a robust, documented handover procedure'
- RR02 (Carry out roadside rectification activities on motor vehicles) -
 - New P8.3 added 'damage to your working environment'
 - New K9 added 'the importance of adhering to a robust, documented handover procedure'
- RR03 (Assess and secure the roadside situation)
 - P4 amended to 'carry out a risk assessment'
 - New P5 added 'continue to assess the situation throughout'
 - New K7 added 'how to carry out a dynamic risk assessment'

- RR05 (Recover Light Vehicles Using Advanced Winching Techniques) and RR07 (Recover Heavy Vehicles Using Advanced Winching Techniques) –
 - These two units to be combined into one unit 'Recover vehicles using advanced winching techniques' (suggest this unit is identified as RR0507 to signpost origins)
 - New P4 added 'continue to assess the situation throughout the winching operation'
 - New P7 added 'promptly inform the relevant authorities where the condition of the vehicle presents a hazard and/or the loading manoeuvre is likely to obstruct the flow of traffic'
 - New P8 added 'use a recovery vehicle and equipment which is suitable for the type, condition and weight of the vehicle to be transported and is suitable for the nature of the incident'
 - New K1 added 'the legal requirements and industry codes of practice governing scene protection and winching operations'
 - New K2 added 'the importance of wearing the appropriate PPE'

- New K7 added 'the limits of your authority for dealing with hazardous substances or alternative fuel vehicles'

- New K19 added 'the importance of carrying out a daily check on the recovery vehicle'

 - New K17 added 'the basic principles of manually handling and manoeuvring a motorcycle'
 - New K18 added 'how and when to engage the assistance of the motorcycle rider in manoeuvring the motorcycle'
- RR10 (Carry out incident management activities for motor vehicle recovery operations) -
 - NO CHANGE
- RR11 (Customer service for emergency motor vehicle operators) -
 - NO CHANGE
- RR12 (Carry out motor vehicle diagnostic testing at the roadside) -
 - New P5.2 added 'work in a way which minimises damage to your working environment'
 - New K7 added 'the hazards associated with working on or near high voltage electrical vehicle components'
 - New K8 added 'the importance of adhering to a robust, documented handover procedure'
- RR14 (Understand technical data, wiring diagrams and manufacturers data on motor vehicles) –
 - NO CHANGE
- RR15 (Carry out Basic Motor Vehicle Repairs at the Roadside)
 - Overview re-worded to include mobilisation of vehicle, type of repair and time constraints.

- New P4 added 'ensure vehicle has been made safe prior to undertaking any activities'
- \circ $\:$ New P5 added 'identify where a minor repair will mobilise the vehicle'
- New P12 added 'ensure handover documentation is completed accurately and passed promptly to the relevant person(s)'
- New K3 added 'the relationship between time, costs and profitability and when recovery is the most efficient solution'
- New K9 added 'the hazards associated with working on or near high voltage electrical vehicle components'
- New K10 added 'the importance of adhering to a robust, documented handover procedure'
- New K11 added 'the importance of informing the customer where temporary work has been carried out'
- RR18 (Give customers at the roadside a positive impression of yourself and your organisation)

- RR19 (Provide technical support and advice to colleagues working at the roadside) -
 - NO CHANGE
- RR20 (Process payment transactions at the roadside)
 - \circ P7 'ensuring personal data is protected' added
