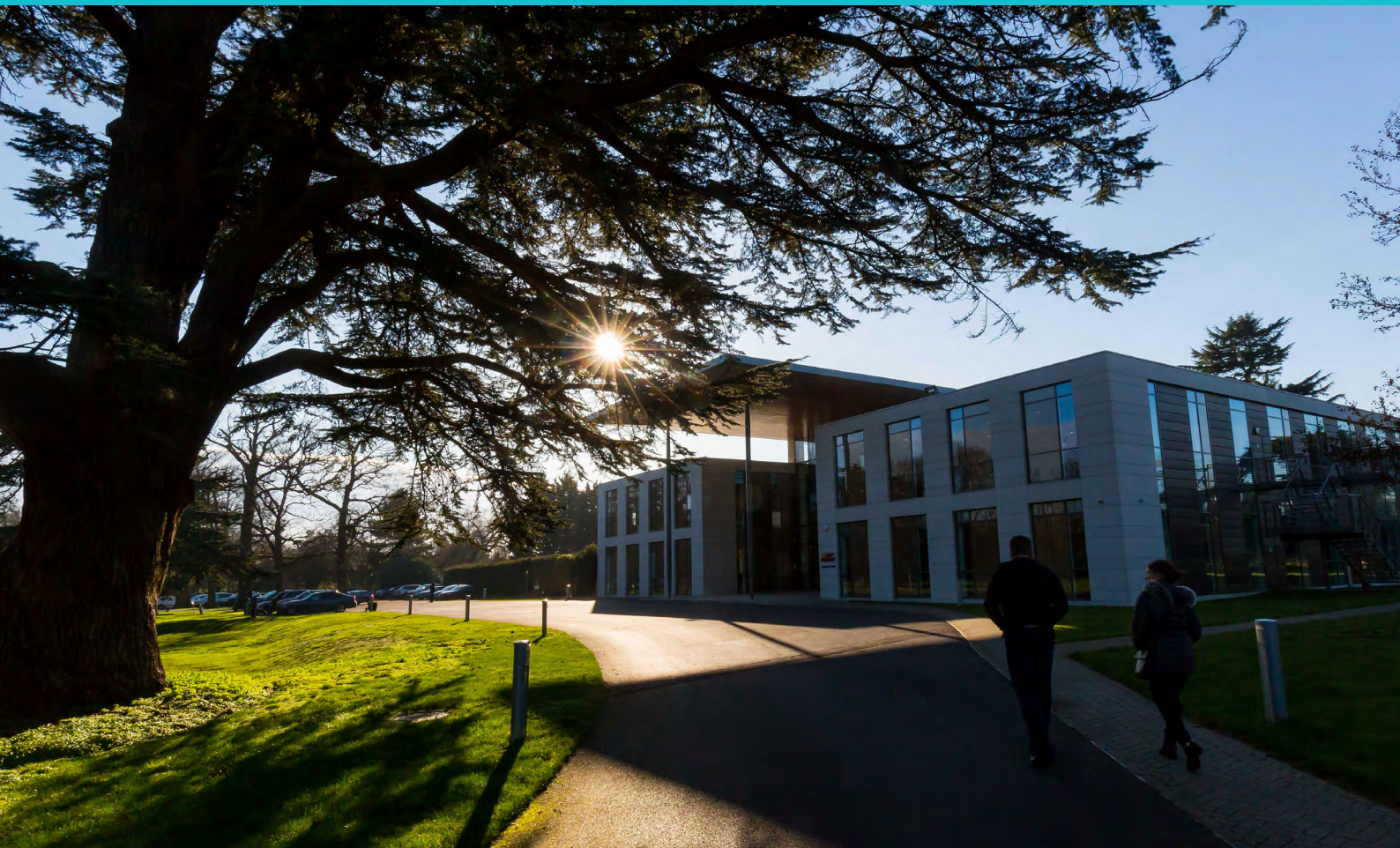

Minimum Spend

IMI has a 'minimum spend' requirement of £1,000.00 per year. When a centre's annual fee is due, the amount the centre has spent with the IMI during the previous year will be calculated. Should this amount be below £1000.00, the centre will be charged the balance along with their annual fee for the forthcoming year.
